- Identification of the personal data processing concerned, including the purpose and the list of personal data processed [Article 30(1)(b) and (c) GDPR]:
 - Debt recovery
 - Purpose of processing: legitimate interest of the controller, performance of the contract
 - Personal data collected: name, address, date of birth, birth number, home address, contact details (phone, email), marital status and family situation, financial situation (income, cost of living), bank account, details of pending/pending/threatened legal/enforcement/administrative proceedings, details of any criminal proceedings and criminal cases
 - Real estate activities, property management and maintenance
 - Purpose of processing: legitimate interest of the controller, conclusion of real estate contracts and their performance
 - Personal data collected: name, address, date of birth, birth number, home address, contact details (tel., email), marital status and family situation, financial situation (income, cost of living), bank account, details of pending/pending/threatened legal/enforcement/administrative proceedings, details of possible criminal proceedings and criminal cases

- From what sources the personal data are obtained [(Article 30(1)(c) GDPR)]:
 - All categories: data subjects, courts and court files, administrative authorities, public registers, publicly available information (e.g. internet)
- Categories of recipients to whom personal data have been or will be disclosed, including recipients in third countries or international organisations:
 - All categories: lawyers, estate agents, tax advisors, notaries, insolvency practitioners, bailiffs, experts, IT firm, energy and other supply suppliers, energy and other network managers.
- When and how personal data is destroyed [Article 30(1)(f) GDPR]:
 - Debt recovery
If the entire claim is settled, no earlier than three years after the controller has fulfilled its tax obligation.
 - Real estate activities, property management and maintenance
If the sale of the subject property takes place, at the earliest three years after the tax obligation of the administrator has been fulfilled.
- Is the information required by law provided to eligible data subjects, in particular on the scope and purpose of the processing, the manner in which the personal data is processed, to whom the personal data may be disclosed?

Yes, this information is available on the controller's website, in employment contracts and in responses to data subjects' requests.

The data subject has the right to:

- (i) access to personal data,
- (ii) to rectify the personal data,
- (iii) to erasure of personal data,
- (iv) to restrict the processing of personal data,
- (v) the portability of personal data
- (vi) to object to processing,
- (vii) lodge a complaint with the Data Protection Authority.
